I understand that if a Change Order is necessary after the contract signing, I will be responsible for any funding needed in excess of the maximum \$5,000 grant; and

I understand that a Promissory Note and Mortgage must be signed in the event that the property is sold or transferred, other than a transfer due to death, of the property rehabilitated with grant funds; and

I understand that if the property is sold or transferred within five (5) years of the completion date, an amount equal to 20% of the grant per year will be re-paid; and full forgiveness will be at the end of the five (5) year period; and

I understand that a Mortgage must be signed as a Security Instrument that the repayment of any debt evidenced in the Promissory Note is satisfied; and

I understand that for multiple properties or façade improvement projects, each location will require a separate application and that each application will be considered on an individual basis; and
